**Release Notes**: Release notes provide a technical summary of the updates made to vaccine code sets and crosswalks. This code set release includes updates for all regular vaccine-related codes plus updates to the CVX to VIS map file. It does not include updates to other Vaccine Information Statement (VIS) codes.

General note regarding this release: Codes with "Last Update" dates from March 19, 2025 and before May 03, 2025, reflect the changes and additions in this release.

# 2. New product: CVX, NDCs, and crosswalks added for 2025 FLUZONE TRIVALENT SOUTHERN HEMISPHERE

One single-dose presentation for the influenza Southern hemisphere 2025 season will be provided by Sanofi. The new formulation is trivalent. A new CVX code has been added to reflect this update. A new product table entry has also been added, "FLUZONE Trivalent Southern Hemisphere." Note that Southern hemisphere influenza vaccines are not associated to CPT codes in the vaccine code set.

# 3. New Unspecified CVX codes 330 and 325 added for unspecified formulations of dengue fever and vaccinia

Non-US dengue vaccine products are now available that do not match the existing US formulation and CVX code for dengue fever. This necessitates the addition of a new unspecified CVX code for dengue to allow for historic vaccine administration to be recorded when the formula/product administered is not known or to record a non-US product dengue vaccine administration.

#### CDC Immunizations Information Systems (IIS) Vaccine Code Set Release Notes

Two formulations for vaccinia (smallpox or mpox) are available. This necessitates the addition of a new unspecified CVX code for vaccinia to allow for historic vaccine administration to be recorded when the formula/product administered is not known or to record a non-US product vaccinia vaccine administration.

Related CVX to vaccine group changes: The DENGUE and Orthopoxvirus vaccine group field in each record "Uncertain Formulation CVX" is now populated with the new unspecified CVX codes as shown below.
