## **County Geography**

The 2023 NCHS Urban-Rural Classification Scheme is the most recent version, following releases of the 2013, 2006, and 1990 (released in 2001) schemes. The NCHS Urban-Rural Classification Scheme is a county-level file that includes the urban-rural classification codes for each of the four versions.

The data file has 3,160 records and because county geography changes over time – names may change, boundaries may shift, new counties are created, or old counties are deleted – the number of counties or county-equivalents in each version of the NCHS Urban-Rural Scheme are not always the same. ## **Specific details for 2013 changes**

**Hoonah-Angoon Census Area, AK** (FIPS code = 02105). In 2007, Skagway-Hoonah-Angoon Census Area (FIPS code = 02232) was split into Hoonah-Angoon Census Area and Skagway Municipality (FIPS code = 02230)..

**Kusilvak Census Area, AK** (FIPS code = 02158). Wade-Hampton Census Area, AK (02270 was renamed Kusilvak, AK and assigned a new FIPS code (02158) effective in 2014.

**Petersburg Census Area, AK** (FIPS code=02195). Petersburg Census Area was created from part of the former Wrangell-Petersburg Census Area (FIPS code = 02280) in 2008.

**Prince of Wales-Hyder Census Area,** AK (FIPS code = 02198). In 2008, Prince of Wales-Hyder Census Area was created from the remainder of the former Prince of Wales-Outer Ketchikan Census Area (FIPS code = 02201) after part (Outer Ketchikan) was annexed by Ketchikan Gateway Borough (FIPS code = 02130 and another part was included in the new Wrangell city Borough (FIPS code = 02275).

**Skagway Municipality, AK** (FIPS code = 02230). In 2007, Skagway-Hoonah-Angoon Census Area (FIPS code=02232) was split into Skagway Municipality (FIPS code = 02230) and Hoonah-Angoon Census Area (FIPS code = 02105).

**Wrangell City and Borough, AK** (FIPS code = 02275). In 2008, Wrangell City and Borough was created from part of Wrangell-Petersburg Census Area (FIPS code = 02280) and part of Prince of Wales-Outer Ketchikan Census Area (FIPS code = 02201).

**Broomfield County, CO** (FIPS code = 08014) was created in 2001 from parts of four Colorado counties: Adams, Boulder, Jefferson, and Weld.

**Oglala Lakota County, SD** (FIPS code = 46102). Shannon County, SD (FIPS code = 46113) was renamed Oglala Lakota County effective in 2014.

**Bedford City, VA** (FIPS code = 51515). In 2013, Bedford City, an independent city, merged with Bedford County (FIPS code=51019).

**Clifton Forge City, VA** (FIPS code = 51560). In 2001, Clifton Forge City, formerly an independent city, merged with Alleghany County (FIPS code=51005).
