This crosswalk lists all topic areas available in the National Center for Health Statistics' National Study of Long-Term Care Providers (NSLTCP) surveys of adult day services providers (ADSC) and residential care communities (RCC), spanning the years 2012 to 2016.

NSLTCP has undergone several changes over the years in protocol design, questionnaire design, and survey item wording. In some years, survey items were added or removed or wording and response options were altered due to feedback from stakeholders. These changes were made to accommodate new topics and provide the most relevant information. To more easily allow data users to locate relevant data on her/his research interests, this crosswalk clearly denotes which content areas were included in each NSLTCP survey year. The first column lists the content areas, categorized by organizational characteristics, services, staffing, and services user characteristics. The second column notes the setting, ADSC and/or RCC. In the next three columns an x denotes which survey year the content was asked about. The sixth column denotes whether the data for that content area can be produced as a national and/or state estimate. Where applicable, the seventh column describes if item or response category wording changed between survey years. The Notes column provides additional information relevant for the user.

NCHS implemented the first study in 2012, 2014, and 2016 and plans to conduct NSLTCP every two years. For 2012 and 2014, the study designs allowed for national estimates and state estimates on all topics. In 2016, there were select topics available in either Version A or Version B that can only be estimated at the national level. For all three survey waves, the services user characteristics are aggregated and the data files are restricted access to ensure confidentiality. NCHS intends that beginning in 2018 and every other survey year (e.g. 2022, 2026, etc), the study design will allow for national estimates only, but will provide user-level characteristics and a public use data file. This crosswalk will be continuously updated as new survey years are available.

NSLTCP was initiated by NCHS to provide reliable, accurate, relevant, and timely statistical information to support and inform long-term care services policy, research and practice. The main goals of NSLTCP are to: (1) estimate the supply and use of paid, regulated long-term care services providers, (2) estimate key policy-relevant characteristics and practices, (3) produce national and state-level estimates, where feasible, (4) compare among sectors, and (5) monitor trends over time. NSLTCP comprises two components: (1) survey data collected by NCHS about adult day services centers and participants, and assisted living and similar residential care communities and residents; and (2) administrative data (claims, assessment, and survey and certification regulatory information) on nursing homes and residents, home health agencies and patients, and hospices and patients obtained from the Centers for Medicare & Medicaid Services (CMS).
