Technical Appendix to the Cohort Fertility Tables for All, White, and Black Women: United States, 2006–2009

Introduction

The cohort fertility tables discussed in this appendix present fertility data from 2006 through 2009 for cohorts of all, white, and black women as they pass through their childbearing years and include central birth rates, cumulative birth rates, birth distributions, and birth probabilities. This set of tables updates the recently published new, as well as revised, cohort fertility tables for 1960 through 2005 [see "Technical Appendix to the Cohort Fertility Tables for All, White, and Black Women: United States, 1960–2005" (1) and detailed cohort fertility tables (2)].

Beginning in 2007, a wider range of maternal age was used for states using the 1989 revision of the U.S. Standard Certificate of Live Birth, expanding from ages 10–54 to ages 9–64, a range consistent with that used for states that have implemented the 2003 revision of the birth certificate (1,4). To accommodate this change to the data file, the "rollback" procedure used for births to women over age 49 was modified, with births to women aged 50–64 being assigned to women aged 45–49 as follows: births for age 50 are assigned to age 45; 51 assigned to 46; 52 to 47; 53 to 48; 54 to 49; 55 to 45; 56 to 46; 57 to 47; 58 to 48; 59 to 49; 60 to 45; 61 to 46; 62 to 47; 63 to 48; and 64 to 49 (1).
