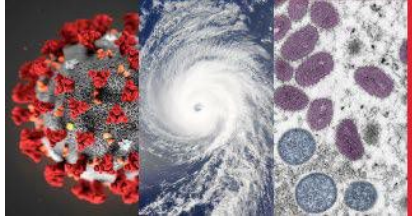

Emergency Response Activities

CDC Activates PHCR Cooperative Agreement to Award H5N1 Response Funding

CDC is activating the Public Health Crisis Response (PHCR) Cooperative Agreement to award funding to support state, local, and territorial public health response to influenza A/H5N1, a novel influenza A virus with pandemic potential, and other potential respiratory disease outbreaks. CDC is awarding more than \$99 million to eligible jurisdictions on the PHCR cooperative agreement's approved but unfunded (ABU) list. Funding is intended to provide resources urgently needed to prevent, prepare for, and respond to the expanding multistate outbreak of novel influenza A/H5 virus and to also strengthen readiness for other potential respiratory disease threats.

In late December, CDC notified the 63 eligible jurisdictions, outlining the two tiers of funding available and general expectations. The two tiers include:

- **Tier 1: \$1.34 million for each of the 63 eligible recipients:** all 50 states, American Samoa, Chicago, Guam, Houston, Los Angeles County, Maricopa County, Marshall Islands, New York City, Palau, Philadelphia, Puerto Rico, U.S. Virgin Islands, and Washington D.C.
- **Tier 2: \$1 million + Tier 1 funding for each of the 15 recipients that are current FluSurv-NET sites:** California, Colorado, Connecticut, Georgia, Maryland, Michigan, Minnesota, New Mexico, New York, North Carolina, Ohio, Oregon, Tennessee, Utah, and Washington.

Sixty-one recipients have accepted the funding opportunity. CDC expects to release the final guidance, reporting requirements, and funding table by Friday, January 17.

SNS January Office Hours to Highlight Radiological and Nuclear MCM Planning Considerations

CDC Invites Organizations to Become Rural Host Sites for Public Health Associate Program

CDC is offering an opportunity for public health organizations to address workforce gaps by becoming a 2025 host site for the Public Health Associate Program (PHAP). This program places motivated early-career public health professionals with organizations to enhance the delivery of public health services, particularly in rural communities.

PHAP provides recent college graduates with a two-year fellowship, funded by CDC, that includes hands-on experience in the daily operations of public health programs. The program aims to support the public health needs of rural areas by placing associates in organizations that serve these communities.

To assist organizations interested in hosting a CDC public health associate, CDC is hosting an informational webinar from **2 p.m. to 3:30 p.m. EST on Thursday, January 23**. This session is a PHAP host site technical assistance call open to all organizations seeking guidance on the application process, featuring discussions on new resources and updates to the application system.

CDC encourages rural-serving organizations to participate in the session, where experienced supervisors

from previous host sites will share insights on the application process and the benefits of hosting a PHAP associate.
